MEETING OPENED: 11:30 AM

ITEM 1: *Phillip Peace* welcomed all Members, Life Members, Patron (Bob Jordan) and declared the 34th Annual General Meeting of Russell Vale Golf & Social Club Ltd open.

ITEM 2: All eligible Financial Members present were requested to sign the attendance register.

ITEM 3: All apologies were required to be listed in the apologies register.

ITEM 4: All Social Members present were reminded that they were not eligible to vote.

ITEM 5: The Minute Secretary presented the minutes of the previous Annual General Meeting held on 29th September 2019.

ITEM 6: The minutes of the previous 33rd Annual General Meeting held on 29th September 2019 were made available to members present.

The **ADOPTION** of these minutes as a true and accurate record was proposed **MOVED**: *Mark Peace*, **SECONDED**: *Jane Davey* and **ENDORSED** by the financial members present.

ITEM 7: BUSINESS ARISING: Nil

ITEM 8: ADOPTION OF REPORTS:

President, Treasurer, Club Captain, Ladies Captain, Juniors, Facility Manager, Sponsorship and Compliance and Health & Safety Reports for 2019/20 were presented for adoption. **MOVED:** *Jane Davey*, **SECONDED:** *Pattie Moore* and **ENDORSED** by the financial members present.

ITEM 9: PRESIDENT'S ADDRESS TO MEMBERS:

Phillip Peace provided an overview of the President's Report in the 34th Annual Report. The 2019/20 financial year was an eventual one for the Russell Vale Golf & Social Club Ltd (the Club). During March to June 2020, the COVID-19 pandemic caused a cessation of golf competitions for five weeks and the Clubhouse was forced to close for nearly 11 weeks. However, the Club was able to manage these unprecedented events on an operational and financial basis.

The Club finished the 2019/20 financial year with a profit of \$24,357, however, this result was assisted by a number of government grants, some COVID related. Even with the cessation of operations for nearly 11 weeks this year, the Club remains in a strong financial position.

Membership at the end of the 2019/20 financial year was 644, a slight decrease of 3.6% from the prior year. Golf competition rounds in 2019/20 were 13,197, a 14.4% decrease on the prior year, predominantly caused by the COVID related course closure for five weeks. However,

post the COVID shutdown, competition rounds have increased to levels not seen for many years – a positive sign.

The Club's golf and pennants competitions were again managed by a great team, led by Alan Sellers and Pattie Moore. With the assistance of the Vice-Captains and other members of the Match & Handicap Committee, the Captains were able to re-organise the 2020 Golf Events Calendar to take account of the COVID-19 five week stoppage in competitions and still run most of the year's major events, including the Championships. All members, from time to time, should show their appreciation to the committed volunteers running the Club's golf competitions. Congratulations to all our players who represented the Club in pennants and other open competitions.

Phillip acknowledged the work of all the club volunteers during the year, without whose efforts the Club would not be able to function. Phillip also thanked the many sponsors and looked forward to their support in coming years.

In May 2020, the Board resolved to change the Club's strategic direction. As Wollongong City Council was not showing direct support and any financial backing for the proposal for a colocated clubhouse and Pro Shop, and the possibility that the Club could incur significant planning and development costs to establish a clubhouse next to the existing Pro Shop; the Club decided to consolidate and invest its resources in the Clubhouse at its current site for the benefit of members.

The Club is now planning for a project to refurbish and refresh the Clubhouse: including new and repositioned bar and kitchen facilities; relocation of the office inside the Clubhouse; new floorcoverings, furniture, additional acoustic ceiling tiles and larger doors opening onto the deck. As the plans develop, the Board will communicate the details to members via the newsletter and website.

Phillip concluded by thanking the volunteer Board members for their work during an unusual year caused by the COVID-19 pandemic. Faced with changes to normal operations, the Board worked in a constructive and pragmatic manner to ensure the safety of members and the continual viability of the Club.

He commended the 34th Annual Report and 2019/20 Financial Statements to all members.

ITEM 10: FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2020: *Phillip Peace* called on **Frazer Davey** to address the meeting. Frazer gave an overview of the 2019/20 Financial Statements and the Daley & Co Independent Audit Report, which included an unqualified and unmodified audit opinion. Frazer Davey reported that the Club had made a profit of \$24,357 in 2019/20 an increase on the prior year profit of \$4,914. Frazer noted that as a result of the Club's strong financial position, and the fact the Club is primarily volunteer run, the financial impact of COVID-19 has been minimal. The Club was able to receive COVID related government support of \$19,000 and further non-COVID related grants of \$17,136, which were used for the deck extension and purchase of a new printer for the office.

When these grant funds and the adjustment for asset write offs and lease accounting changes are separated from the result; the Club generated an operating surplus of \$5,803. This was a pleasing result given the extraordinary events in the last quarter of the 2019/20 financial year. The Club remains in a healthy financial position with substantial assets over liabilities and cash balances just under \$513,000.

ITEM 11: ADOPTION OF AUDITOR'S REPORT:

ORDINARY MEMBERS – Ordinary members shall be those accepted for membership by the Board of Directors and who are over the age of twenty-one years and shall be subject to such playing rights and other conditions or restrictions as to the use of its club house and amenities as the Board of Directors may from time to time determine. Ordinary members include Pensioners, Patron, Honorary Members, Corporate Members and Youth Members who shall be entitled to vote at General Meeting of the Company.

Junior members shall not be entitled to vote at any General Meeting of the Club.
